Overview

Coral Stone Insurance SPC, Ltd. (Coral Stone) is a Cayman Islands based specialty insurer and reinsurer facility for organizations looking for a third party risk transfer financing vehicle to establish a Segregated Portfolio or Portfolio Insurance Company. Coral Stone was incorporated on November 25, 2020 and was granted its Class B(iii) insurance license from the Cayman Islands Monetary Authority on December 7, 2020. The purpose of the formation of the Company was to provide a specialty insurer and reinsurer facility to SRS clients.

Definitions and Operations

What is a Captive? A captive insurance company is an insurance company owned and controlled by its insured(s) with the primary role of insuring the risk exposure of its owner(s) and affiliates.

What is a Segregated Portfolio Company ("SPC")?

A unique form of company that legal allows the separation of assets and liabilities within the law via the formation of Segregated Portfolios ("SP"). Also known as segregated cell facility in other domiciles.

What is a Portfolio Insurance Company ("PIC")?

A unique feature of the law that allows the segregated facility to be incorporated. A Segregated Portfolio is formed for the sole purpose of owning the separately incorporated PIC.
